**THE UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 25A**

BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Prof. G. L. Peiris, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act in respect of the CINEC Campus (Private) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PV 17745, do by this Order, amend the Schedule II to the Order made under the said Act, and published in *Gazette Extraordinary* No. 2157/3 of January 6, 2020 by the addition immediately after the entry “Bachelor of Business Management Honours in Banking and Finance” appearing in Column I and its corresponding entry in Column II thereto, of the entries specified under Column I and II respectively of the Schedule II hereto, subject to the conditions specified in Schedule I hereto :-

**SCHEDULE I**

**Conditions**

1. CINEC Campus (Private) Limited shall, when admitting students for the degree programme specified in Schedule II hereto in respect of the Master of Business Administration by course work (SLQF Level 9), adhere to the minimum entry qualification of ;



- (a) A Bachelor's degree,
- (i) Including 30 credits in the relevant subject areas of Management or Business and Economics ; or
- (ii) With prior learning or work experience in the subject areas of Management or Business, equivalent to 30 credits in the relevant subject area ; or
- (b) A qualification in the relevant subject area of Management or Business and Economics equivalent to (a)(i) or (a) (ii) above ; or
- (c) The successful completion of NVQ Level 7, as determined by the Specified Authority.

as prescribed in the Sri Lanka Qualification Framework (SLQF), and shall adhere to the condition that, the name of qualification shall not have any qualifier or specification attached to it.

2. CINEC Campus (Private) Limited is allowed to offer the degree specified in Schedule II hereto, subject to the programme re-review conducted by the Specified Authority.

**UNIVERSITIES ACT, No. 16 OF 1978**

**Order under Section 20(4)(b)**

BY virtue of the powers vested in me by Section 20(4)(b) of the Universities Act, No. 16 of 1978, I, Professor G. L. Peiris, Minister of Education, on being satisfied that the administration of the affairs of the Gampaha Wickramarachchi Ayurveda Institute have been seriously dislocated and that the authorities of the said Institute have failed to restore normal conditions, do by this Order, appoint Senior Professor Janitha Abeywickrama Liyanage to be the Competent Authority with effect from December 13, 2020 for the purpose of exercising, performing and discharging in lieu of the Director of Gampaha Wickramarachchi Ayurveda Institute, any power, duty or function respectively which has been conferred or imposed on, or assigned to the said Director under the said Act, or any Order, Ordinance, Statute, By-Law, Regulation or Rule made thereunder.
