BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Prof. G.L. Peiris, Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the Royal Institute Colombo (Private) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing registration number PV 9729 and located at No. 92, Sunethra Devi Road, Kohuwala 10250, Nugegoda do by this Order and subject to such conditions as specified in the Schedule I hereto, recognize the Royal Institute Colombo (Private) Limited as a Degree Awarding Institute for the purpose of developing Higher Education therein, leading to the award of the Degree specified in Column I in the Schedule II hereto, of which the abbreviation is set out in the corresponding entry in Column II in Schedule II hereto.

2. The minimum entry qualification for admitting a student shall be-
 - (a) three (3) simple passes (S) in the Commerce subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent; or
 - (b) three (3) simple passes (S) in any subject stream in one and the same sitting at the GCE (Advanced Level) Examination conducted by the Department of Examinations of Sri Lanka with a bridging course approved by the Specified Authority.
3. Every five (5) years from the date of publication of this Order a Subject Re-review shall be conducted by the Specified Authority in order to offer the degree specified in the Schedule II.
