




ELIGIBILITY +

- A. Foreign national middle school students, graduates, or those with equivalent educational background are eligible to apply
- B. Applicants with foreign citizenship
- C. Applicants who hold Korean Citizenship (dual citizenship) are not eligible to apply as foreign students
- D. International applicants MUST ADDITIONALLY satisfy one of the following two requirements:
 - a. Neither of the applicant's parents is a Korean citizen, or;
 - b. For applicants of Korean Origin, he/she must have received his/her entire elementary and junior high education outside of Korea at a comparable and equivalent level of that provided in Korea.

Applicant of Korean origin who completed their entire education (elementary and junior high) outside of Korea should submit the Certificate of the Facts Concerning the Entry & Exit issued by the Korean Immigration Office. The certificate should have recently been issued.

- E. Note that international schools located in Korea are NOT acknowledged as foreign schools.
- F. Applicants who completed or will have completed middle schools in Korea are also welcomed to apply to KSA.

B. Application Documents in Details

- Application Form
- Complete application online (https://admission.ksa.hs.kr/english)
- Passport or National ID Copy (Applicant & Parents)
- Submit a copy of your international passport, national ID card or an official document that verifies your nationality.
- Make sure to include a copy of the page that shows your passport number, date of issue and expiration, photo and name. (Valid until at least August 31, 2025)
- Certificate of Facts
 Concerning Entry
 & Exit (Korean origins
 only)
- A certificate issued by the Korean Immigration Office within two months of the application deadline is required. This certificate must show all entry and exit records from the applicant's date of birth up to the date of submission.
- Please be aware that admission may be negatively affected or rescinded if false information is found in the submitted materials, or if entry/exit records cannot be verified due to the use of dual passports.
- If obtaining the Certificate of Entry and Exit Records directly proves difficult, applicants may request a third party residing in Korea to obtain the certificate on their behalf. To do so, they will need to provide a copy of their passport, a power of attorney, and an application form. The Korea Immigration Service can be reached at +82-1345.
- O Personal Statement

- One Recommendation Letter
- Only ONE recommendation letter from a teacher will be taken into consideration.
- -The recommendation letter is highly encouraged to be written by an academic advisor, homeroom teacher, or a math/science teacher.
- The letter must be written in English.
- G Official Academic Records notarized in English (over the recent three years)
- Submission of official transcripts from all junior high attended is mandatory.
- Transcripts must include year-by-year records of all coursework including any coursework currently in progress.
- If available, the transcripts may also include a statement of personal rank in class/grade.
- (over the recent three years)
- Applicants may submit up to three honors or awards (preferably in math or science) obtained during their junior high school years.
- -The list of honor and awards will only be considered valid if certificates or evidence are submitted along with it.

SELECTION PROCESS +

KSA takes into consideration a number of factors when determining admission, including the applicants'academic achievements (especially in math and science), potential, interpersonal skills, personal accomplishments, integrity, and leadership.

1st Stage: Written Test (Mathematics)

- The 1st Stage of the written test will be conducted online, and the manual of online test system will be uploaded on the notice board at KSA admission website(https://admission.ksa.hs.kr/english) as soon as the application is closed.
- It is strongly advised to read the manual thoroughly and familiarize yourself with the online test system.
- All applicants are requested to ensure that they have the necessary setup for online testing, which is an stable network environment with a secure access to a computer, a monitor, a web-cam and a mobile phone.
- KSA assumes no responsibility for any issues arising from the unavailability of prerequisite for online testing.

2nd Stage: Documents Review and Interview (Mathematics & English)

- The 2nd Stage applications are open exclusively to candidates who successfully passed the 1st Stage.
- Further details regarding the 2nd Stage will be communicated to eligible candidates in due course.

PRE-ENROLLMENT EDUCATION FOR ADMITTED STUDENTS +

- A. Online education for admitted students encompasses Mathematics, Science, English, and Korean.
- B. Mandatory participation in pre-enrollment education is required for all admitted students.
