Stipendium Hungaricum Undergraduate Scholarships Hungary 2026/27

Applications are invited from eligible Sri Lankans for the award of **eight (08)** undergraduate scholarships offered by the Government of Hungary under the bilateral cooperation between the Government of Sri Lanka and the Government of Hungary on Program of the Stipendium Hungaricum Scholarship program for the academic year 2026/27.

01. General eligibility requirements:

- (a) Should be a citizen of Sri Lanka.
- (b) Applicants should be **over 18 years old as of 31st August 2026**
- (c) The applicant should have a minimum of three passes at the 2024 G.C.E. (A/L) Examination in the relevant fields of study conducted by the Department of Examinations, Sri Lanka.
- (d) Should possess a good knowledge of English. (Should have obtained at least a “C” pass in English at the G.C.E. (O/L) Examination and “S” pass at the G.C.E A/L Examination)
- (e) Applicants are required to fulfill all the eligibility criteria on or before 15th January 2025.
- (f) Should be in good health and ready to live in Hungary during the period of study.
- (g) Applicant should not be enrolled or following an undergraduate degree at a state university in Sri Lanka as an internal student (a student selected by UGC based on the G.C.E. A/L results).

02. Fields of study:

- (a) In the fields of Science, Technology, Engineering, Mathematics (STEM), Agriculture (<https://stipendiumhungaricum.hu/partners/>)
- (b) Available study programs and host institutions are accessible in the online application system (<https://apply.stipendiumhungaricum.hu/>)

03. Medium of instructions: Study programs are generally available in the English and Hungarian Languages.

- Students shall have a level of proficiency in the language of education as required by the Host institution. The applicants are needed to apply directly for the study program in the online application system.

04. Terms of Award:

- (a) Selected candidates shall be responsible for the international roundtrip cost.
- (b) Exemption from the payment of tuition fee
- (c) Monthly stipend of HUF 43,700 (cca EUR 110) contribution to the living expenses in Hungary, for 12 months a year, until the completion of studies.

(d) Accommodation contribution:–

Free dormitory place or a contribution of HUF 40,000/month an accommodation cost for the whole duration of the scholarship period (Please note that if the student does not live in the dormitory, the HUF 40,000/month is a contribution to that rental costs, and in bigger cities-especially in the capital city-this contribution would not cover the full amount of rental costs).

(e) Medical Insurance:–

Health care services according to the relevant Hungarian legislation (Act CXXII of 2019, on entitlements to Social Security Benefits and funding these services) and supplementary medical insurance for up to HUF 65,000 (cca EUR 165) a year /person.

These provisions are **only a contribution** for the living expenses of the scholarship holders. It means that **it does not fully cover all the costs of living and the students need to add their own financial resources** in order to cover all living expenses in Hungary. 05. Special Notes:

- (a) Candidates who are awarded this scholarship would not be considered for university admission process of the University Grants Commission of Sri Lanka.
- (b) Award of the scholarship conditions laid down in this notification may vary as per the criteria imposed by the Hungarian authorities, without prior notice.

- (c) Candidates who received scholarships would select the Higher Educational Institutes recognized by the University Grants Commission of Sri Lanka.
- (d) If any student declines the offer after the selection process, he/she shall not be considered for any of the scholarships in future.
- (e) Extension of the period of the scholarship will not be recommended by this Ministry.

06. Applications:

07. Interview & Selections:

- (a) The Hungaricum scholarship awarding authority will forward the eligible list to this Ministry after having the technical checkup.
- (b) The Eligible candidates will be shortlisted based on their academic merit (Z. score) and will be called for an interview by the Ministry of Education, Higher Education and Vocational Education at a short notice.
- (c) The Nomination will be forwarded to the Hungaricum scholarship awarding authority for final selection. No candidate should treat his/her nomination for this Scholarship as the confirmation of the award is a matter entirely within the discretion of the Hungarian awarding authority.
- (d) Any form of canvassing either written or verbal will be considered as a disqualification for a scholarship.
