**Romanian Undergraduate Scholarships – 2026/27**

Applications are invited from eligible Sri Lankan applicants for the award of **02** Undergraduate Scholarships offered by the Government of Romania for the academic year 2026/27.

**01. General Eligibility requirements: -**

- (a) Applicant should be a citizen of Sri Lanka.
- (b) The applicant should have a minimum of three passes at the G.C.E. (A/L) Examination- **2024 or 2025 in any stream**, conducted by the Department of Examinations, Sri Lanka.
- (c) Should possess a good knowledge of English. (Should have obtained a “C” pass in English at the G.C.E. (O/L) Examination and “S” pass at the G.C.E A/L Examination or equivalent.
- (d) Should be in good health and ready to live in Romania during the period of study.
- (e) Applicant should not be registered or following a course at a state university in Sri Lanka as an internal student (a student selected by UGC based on the G.C.E. A/L results).
- (f) Candidates who do not hold Romanian citizenship or the citizenship of a European Union/ Swiss Confederation/ European Economic Area member state, with the exception of European Union countries for which a letter of agreement is in force.
- (g) Candidates who are not members of the diplomatic corps or family members of the diplomatic corps accredited in Romania.
- (h) Candidates who did not benefit from a scholarship granted by Romania for the same study level. (Bachelor studies)

**02. Field of Study: Any fields of study, except studies in medical professions**

**03. Medium of Study: - Romanian Language**

**Note: The preparatory year of Romanian language is included in the scholarship for selected candidates**

#### 04. Terms of Award:

- (a) Tuition and enrolment fees.
- (b) Accommodation in student dormitories within the national subsidy limit. (This may lead to additional costs for students, as set by the host university).
- (c) A monthly allowance of 925 lei;
- (d) Medical assistance in case of medical - surgical emergencies and potentially endemic diseases.
- (e) The cost of air ticket to Romania and back should be borne by the student.

#### 06. Special Notes:

- a) Candidates who are awarded this scholarship would not be considered for university admission process of the University Grants Commission of Sri Lanka.
- b) Scholarship conditions laid down in this notification may vary as per the criteria imposed by the Romanian Government without prior notice.
- c) If any student declines the offer after the selection process, he/she shall not be considered for any future scholarships that offered by Ministry of Education, Higher Education and Vocational Education.
- d) Extension of the period of the scholarship will not be recommended by this Ministry.

#### 05. Applications:

- a) Online application is available at: <https://foreignscholarships.mohe.gov.lk/>
- b) **The deadline of the submission of the application is 12<sup>th</sup> May 2026**
- c) **Applicants should submit only one application via online portal and not required to send the printed document by post.**
- d) Any statement in the application, which is found to be incorrect/false will liable to disqualification at any time and will lead to the withdrawal of the award.
- e) Any application which is incomplete in any respect or received late, will be rejected.

#### 06. Nominations & selections:

- a) Candidates will be shortlisted based on their Z score and will be called for a structured interview by the Ministry of Education, Higher Education and Vocational Education, with a short notice via email in due course.

- b) The Nomination will be forwarded to the Romanian Embassy in Sri Lanka and the final selection will be made by the Government of Romania as the awarding authority. No candidate should treat his/her nomination for this Scholarship as the confirmation of award is a matter entirely within the discretion of the awarding authority.
- c) Any form of canvassing either written or verbal will be considered as a disqualification for a scholarship.
- d) The final decision regarding the award rests solely at the discretion of the Secretary of this Ministry.
