UNIVERSITIES ACT, No. 16 OF 1978

Order under Section 25A

BY virtue of the powers vested in me by Section 25A of the Universities Act, No. 16 of 1978, I, Dr. A. D. Susil Premajayantha, the Minister of Education, having obtained a report under Section 70C of the aforesaid Act, in respect of the Gateway College (Private) Limited, a company incorporated in Sri Lanka under the Companies Act, No. 7 of 2007 and bearing Registration Number PV 7161 and located at No. 185, Koswatta Road, Rajagiriya do by this Order subject to such conditions as specified in Schedule I hereto, recognize Gateway College (Pvt) Ltd as a Degree Awarding Institute for the purpose of developing Higher Education therein, leading to the award of the Degree specified in Column I of the Schedule II hereto, of which the abbreviation is set out in the corresponding entry in Column II of the Schedule II hereto :-

SCHEDULE I

CONDITIONS

1. The Gateway College (Private) Limited (hereinafter referred to as the “institute”) shall, when admitting students for the degree programme specified in Schedule II hereto in respect of the Bachelor of Education Honours with a minimum of 120 Credits (SLQF Level 6), adhere to the minimum entry qualification of ;
 - (a) At least three (3) Simple Passes (S) in any stream in one and the same sitting at the G.C.E. (Advance Level) Examination conducted by the Department of Examinations of Sri Lanka or equivalent qualification.

2. The Institute shall conduct the degree programme in relation to the specified in Schedule II hereto, only at No. 185, Koswatta Road, Rajagiriya, Sri Lanka.
3. The Institute is recognized to offer the Degree specified in Schedule II hereto, subject to a review conducted by the Specified Authority every five (5) years from the date of publication of this Order.
