Required Qualifications for the Post

1. Project Engineer (PS 4)

Minimum Qualifications & Experience:

A qualification recognized by the University Grants Commission as an equivalent qualification to the Degree in the relevant field

Or

An Associate Membership / A similar professional qualification obtained from a recognized professional institution in the relevant field

With

At least 08 years post qualifying experience in the relevant field

(2). An officer of the Government All Island Services Class III/II or above or similar status in the relevant field

With

At least 08 years of experience in Class III/II post

General Conditions

1. It is compulsory to fulfil all the qualifications relevant to post by each applicant on or before the date of calling applications.

2. Experience in foreign funded construction development project will be a special qualification.

3. **Age Limit:** Maximum age of 64 years or less than that

4. **Salary :** Salary and other allowances entitled in terms of the Circular No. 01/2019 dated 05.03.2019 issued by the Department of Management Services of the Ministry of Finance.

5. Service Conditions:

Will be appointed to one-year duration on contract basis. It will be considered to extend that period annually for considering the performance and the service requirement.
